## CATEGORIES OF MEMBERSHIP

**Massachusetts Domiciled For-Hire Carriers** are those motor carriers whose corporate headquarters are located in Massachusetts. The dues are calculated based on the gross revenue of the company. Please see dues computation below.

**Private Carriers** are those who operate dedicated fleets of vehicles transporting their own goods. Also included in this category are truck leasing companies and contract carriage fleets. The dues are calculated based on number of vehicles as reported to DOT. Please see dues computation below.

**Non-Domiciled Carriers** are those whose corporate headquarters are located outside the state of Massachusetts. The dues are calculated based on miles traveled in Massachusetts. Please see dues computation below.

**Associate Memberships** are equipment manufacturers, vendors and service providers to the trucking industry. **Associate members pay a flat fee of \$650.00 annually.**
